GOLD MEMBER

Gold Members, in good standing, shall be entitled to the full use of the Club Facility.

SILVER MEMBER

Silver Members are 21 to 45 years of age. A Silver Member, in good standing, shall be entitled to the full use of the Club Facility.

SOCIAL

Social Members, in good standing, shall be entitled to the full use of the Club Facility except the golf course. Social members may play golf when they choose, but must pay the prevailing guest rate and are limited to using the putting green and practice facilities on the days they play.

NON-RESIDENT MEMBER

A Non-Resident Member, in good standing, shall be entitled to the full use of the Club Facility. A Non-Resident Member maintains his/her principal residence outside of Pierce or any adjoining counties. Residents of Pierce and all adjoining counties, for purposes of membership, are considered to be residents. Individuals owning or renting, for any period of time, a residence in Pierce, Ware or any contiguous county will not be considered for a non-resident membership regardless of the individual's legal residence.

JUNIOR MEMBER

Junior Members are 16 to 20 years of age. A Junior Member, in good standing, shall be entitled to the full use of the Club Facility.

INITIATION FEES

Initiation fees have been reinstated for any returning member who wishes to rejoin within 3 years of resigning from the club.
